Highlights from February 28, 2023

Clark Whitley was our recent speaker at our February meeting. He is a Development Officer on the Ministry Relations team for First Liberty Institute. If you have not heard of First Liberty, I bet you have definitely heard of many of the key cases they are pursuing, have pursued and won.



Defending the right of students to religious free exercise in school:

School Backs Down After Confiscating 2nd Grade Little Girl's Bible at School – a second grader in Illinois liked to bring her Bible to school and read it during recess. Sometimes she read it aloud, and sometimes other kids would listen in and talk with her about what she's reading but she had her Bible taken away by a teacher and was told, "You just can't be doing that."



Defending Religious Beliefs: Military vaccine case

First Liberty represents the 35 U.S. Navy SEALs whose careers and livelihoods are being threatened because of their religious beliefs because they chose not to get a vaccine due to their convictions of faith. Biden administration and military officials have pursued a punitive and vindictive approach toward service members who requested a legal, religious accommodation to the vaccine mandate.



Defending religious accommodation: The faithful Postal Carrier

Gerald Groff was forced to quit his job as a postal carrier because of his religious beliefs. He believes in the Christian Sabbath, but the USPS refused his religious accommodation request not to work on Sundays after initially granting his request. First Liberty is fighting this blatant discrimination at the U.S. Supreme Court, making it clear that federal law requires reasonable religious accommodations.



Defending private act of worship: Comeback Coach- Joe Kennedy

In 2008, Bremerton High School football coach, Joe Kennedy, made a promise to God that he would pray and give thanks after each game he coached, regardless of the outcome. This commitment to a simple, private act of worship caused him to be stripped of his position as a coach and forced him into a lengthy, ongoing legal battle against the school he faithfully served. Although the courts denied his constitutional rights, Coach Joe—a former Marine—didn't back down. And now, he's finally got victory at the highest court in the country - the U.S. Supreme Court.



Defend to end religious discrimination - Treat Children Fairly: Let Parents Choose

Maine's law blatantly discriminates against parents based on religion, providing some families with tuition support for the school of their choice but denying that same support to other families. The families who filed the lawsuit qualify for Maine's tuitioning program in all other respects, but they are excluded from participating only because they chose religious schools for their children.

Constable Phil Sandlin



Phil was raised in southeast Houston attending school in the Pasadena Independent School District. Growing up, Phil was very active in Future Farmers of America raising livestock to show in the Pasadena Livestock Show and Rodeo. After graduating from Dobie High School in 1987, Phil attended San Jacinto College majoring in Criminal Justice. In 1990, he accepted a job with the Harris County Sheriff's Office as a civilian jailer. In 1991, Phil graduated from the Sheriff's Academy as a certified peace officer and was assigned to the Detention Bureau.

He left the Sheriff's Office in 1992 and accepted a job with the Harris County Precinct 8 Constable's Office as a patrol deputy. Over the years, he rose through the ranks at Precinct 8, being promoted to Corporal, Sergeant, Lieutenant and Captain. In February 2005, Phil was appointed to the rank of Chief Deputy of Precinct 8 where he oversaw the day to day operations of the agency. On June 1, 2011 he was appointed Constable by Commissioner's Court before winning the 2012 election decidedly to keep the position.

"I am proud to have served the citizens of this community for over 31 years and I want to continue serving as Constable. Giving back to this community, keeping our families safe and protecting our streets are my top priorities. I have always striven to build a strong relationship with both the citizens of this community and with the various other law enforcement agencies in our area. As a result, our department receives calls on a daily basis from citizens who know they can count on Precinct 8 to respond quickly to their needs. It is also common for other law enforcement agencies to call on us when they need assistance. I am proud of these partnerships and without a doubt; we have a solid reputation in this community. I intend to keep it that way".

"I entered this leadership position with somewhat of a unique perspective on what the job requires and what is expected of me. This is certainly not the time for an inexperienced leader who does not understand the complexity of running an agency. I have dedicated my career to serving the citizens of Precinct 8 and I believe in leadership through honesty, integrity, professionalism and fiscal responsibility. These are not just words to me but rather are the principles on which I have built my career. I have served over 20 years in a supervisory position, many of which have been in upper management and I know what it takes to run this department and do so effectively."

"With the overwhelming public support I have received, along with the hard work and dedication of the many fine men and women that make up the Precinct 8 family, I am proud to be leading this agency into the future. I do not take my oath of office lightly and I pledge to continue working hard every day to continue earning the trust of this community".

Over the course of his 31 year career in law enforcement, Constable Sandlin has been proud to serve the citizens of this community and volunteers much of his time to area civic groups and organizations. He and his family are members of South Main Baptist Church in Pasadena. He and his wife Nerissa, who is an In-Flight Supervisor for Southwest Airlines, reside in Deer Park and have two sons, Blake and Clayton. Phil is a member of the Pasadena Livestock Show and Rodeo and the Houston Livestock Show and Rodeo. He is a master mason and member of the Deer Park Masonic Lodge #1362. Phil has been a member of the Space Center Rotary Club since 2006 and is the Chairman of the Excellence in Public Service Committee. In his spare time, he enjoys spending time with his family and traveling.

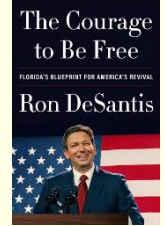

The Courage to Be Free by Ron De Santis

No American leader has accomplished more for his state than Governor Ron DeSantis. Now he reveals how he did it.



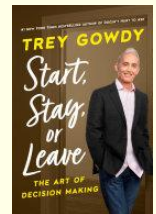

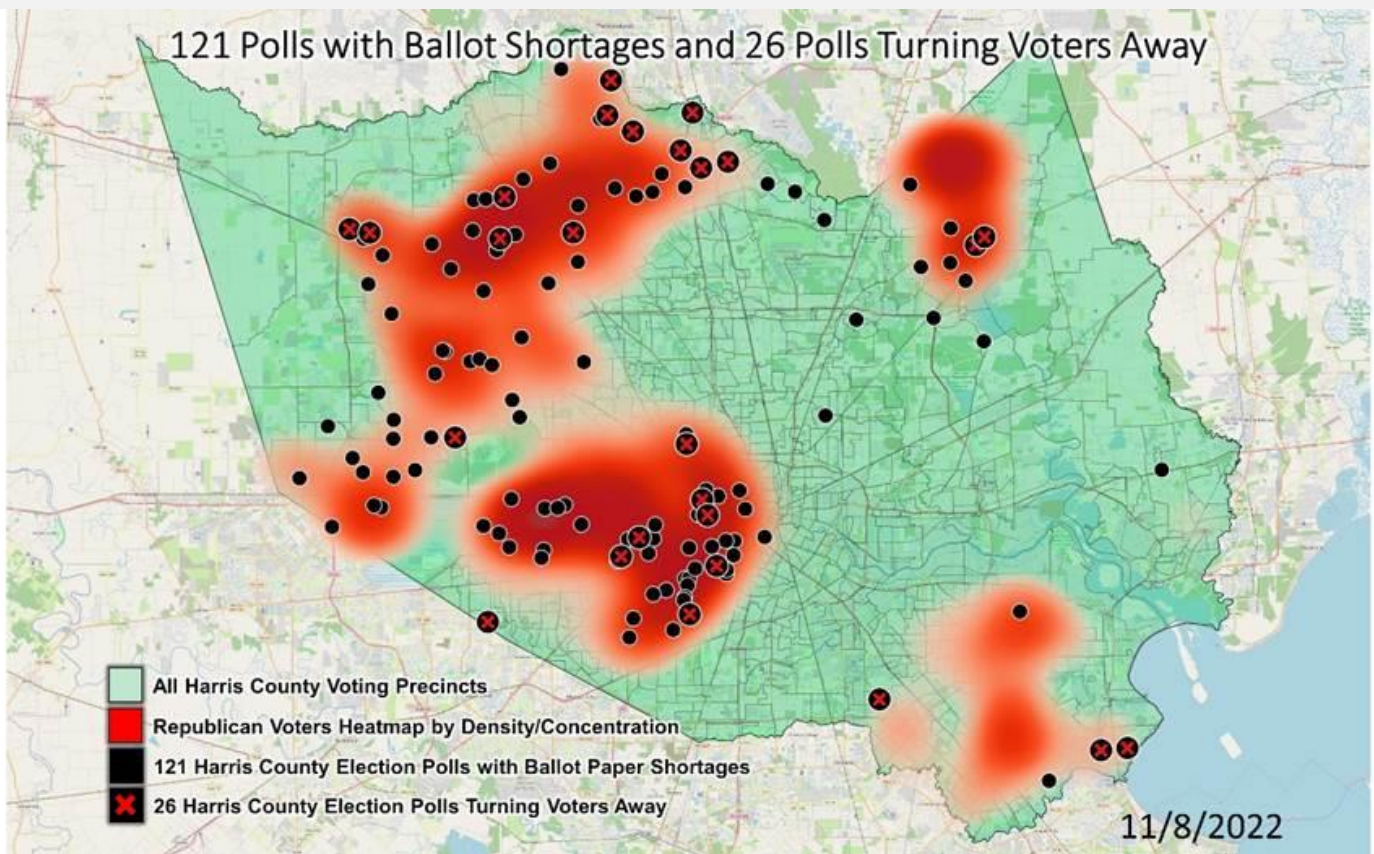

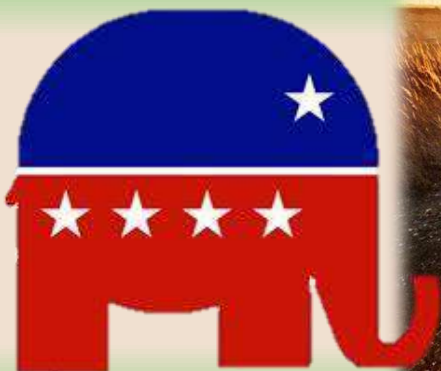
Caring for America

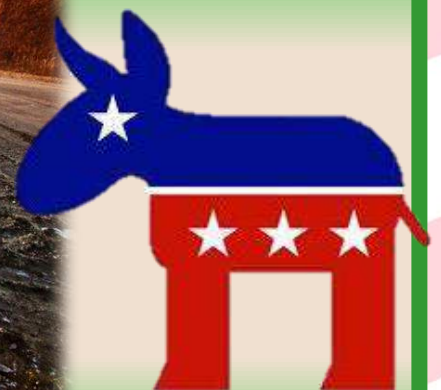

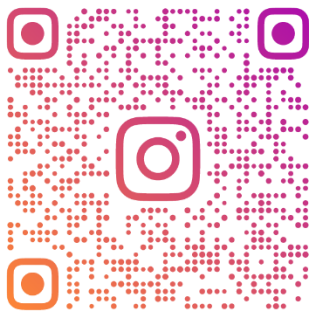
