## Highlights from May 23, 2023

The May 23, 2023 BARW breakfast meeting was honored with our guest speaker, [Dr. Karen Engle](#). Dr. Engle was officially named to the Superintendent of Schools for the Clear Creek Independent School District in December 2022.



She began her remarks on some of the statistics of the district –

- Clear Creek ISD serves approximately 40,000 students across 45 campuses, consisting of 5 comprehensive high schools, 3 alternative high schools, 10 intermediate schools, and 27 elementary schools.
- The district is 103 square miles and covers 12 municipalities, like Clear Lake Shores, Nassau Bay, Taylor Lake Village & Webster. CCISD also serves portions of Friendswood (Harris County portion), Houston (Clear Lake City), League City and Pasadena.
- The district employs over 5,000.

Dr. Engle talked about her Vision 2030. Why 2030? This is the year our current 5th graders will graduate. The focus of this vision is instruction, culture and learning systems. She proposes by 2030, the district will offer pre-k to all district families. It will be a “Leader In Me” district (which is modeled by Stephen R. Covey’s principles of leadership and how they can be applied to children of all ages). All intermediate schools will be centers of innovation, creation and collaboration. All graduates will be creators, critical thinkers, collaborators, contributors, communicators, connectors, compassionate and confident.

She discussed a bit about the Wave Program. There are two locations: WAVE North at Westbrook Intermediate and WAVE South at League City Intermediate. This program provides a nurturing environment for students to enhance their executive functioning skills. Other programs offered at various CCISD schools are E-STEM Magnet, Robotics and Coding and Science Magnet.

Dr. Engle weighed in on how CCISD had approved to change the class ranking policy starting with the class of 2027. Class rank will now be determined by a system that uses only courses in English Language Arts (non-elective), Math, Science, Social Studies (non-elective), and World Languages and Culture. Under this proposal, students may take electives they desire without impacting their class rank status.

She explained a bit about the 2023 Facility Advisory Committee and its charge to formulate recommendations to the [Board of Trustees](#) on how to address the district’s potential budget shortfall and plans to communicate to the public the financial struggles they face going forward like many school districts across the state are facing. You can read [here](#) for additional information.

She mentioned how CCISD continues to have the [lowest tax rate](#). Clear Creek ISD approved its 2022-23 tax rate at \$1.1146 per \$100 of valuation, continuing its streak of lowering the annual rate.

Dr. Engle is quoted as saying “For me, the CCISD star represents the shining light of hope of education that our District has been for me personally and for thousands of students over the decades. I am excited to look ahead at what is possible for the next generation of Clear Creek ISD graduates.”

## Next Meeting - August 22, 2023

Audrey Young, a Republican, was elected to the State Board of Education in November 2020 representing parts of the Greater Houston and Southeast Texas area. Audrey is married to Reverend Scott Moore, pastor of Wesley Memorial United Methodist Church and Deputy Sherriff for Trinity County. Her daughters: Amanda and AmyBeth are college graduates and work full-time in their field of expertise.

Young is the Director of Student Support Services for Nacogdoches ISD. She earned an associate's degree in Education from South Florida State College, bachelor's degree in Communication Sciences and Disorders from the University of Central Florida, a master's degree in Curriculum and Instruction, an Educational Specialist degree in Educational Leadership, and a Doctorate of Education from Stephen F. Austin State University.

Her career spans over 29 years in public education as a speech therapist, reading specialist, middle school administrator, and district director. Following her exemplary service as a Master Trustee for Apple Springs ISD in Trinity County (6 years), a former two-term member of the Executive Board of Leadership – Texas Association of School Boards Alumni Association (LTASBAA), a 3-term member of the TASB Legislative Advisory Council (LAC) representing Region 6, and two years on the Texas Education Agency (TEA) Board of Trustees Advisory Committee, Young wrote her doctoral dissertation on the connection between the school board, within their perceived roles and responsibilities, and their relationship with the superintendent. Young wrote, *"School board members are expected to make important decisions that directly impact students without having been provided the political, financial, educational, or statutory training necessary for such monumental tasks. Boards are as honest to their role as superintendents are to theirs."* In her spare time, Dr. Young volunteers as a dance teacher for the Adaptive Dance class at No Limits Dance Center of Nacogdoches, serving children with disabilities through dance and movement.

Young is a 9th generation of the Rose family to reside in Texas and her family is recognized by the Texas State Historical Society as a Texas First Family. Her family member: John Washington Rose was elected to the very first Texas Legislature in 1846, representing Victoria County. Following the legacy of the Rose family, 176 years later, Dr. Young now serves as an elected State Official. She is the Literacy Chair of the Daughters of the American Revolution, Anthony Smith Chapter and the Daughters of the Republic of Texas, Mary Hall Mantooth Chapter. She is the President of the Nacogdoches Chapter of the American Association of University Women, a board member of the Apricity Foundation, a lifetime member of the Montgomery County Fair Association, a lifetime member of the Houston Livestock Show and Rodeo serving on the Scholarship Administration Committee and the Speakers Committee and is the First Lady of WMUMC. Young was recently honored as a recognized Alumni from both South Florida State College and University of Central Florida. She was named 2021 Educator of the Year in Special Services from the Association of Texas Professional Educators, awarded the 2021 State of Texas 4-H Salute to Excellence Award for District 5, named a 2022 Friend of Education by Sam Houston State University, awarded the 2023 Woman of the Year special recognition as an Outstanding Advocate by the American Association of University Women Nacogdoches Branch, and recognized as the 2023 Area 5 CTAT Champion of CTE Award.



As a member of the State Board of Education, Young represents District 8 with about 1.9 million Texans who reside in 11 counties: part of Ft. Bend, part of Galveston, Grimes, part of Harris, Houston, Polk, part of Montgomery, San Jacinto, Trinity, Walker, and Waller counties.

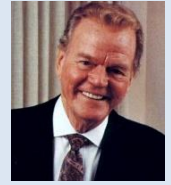
