Judge Ken Wise, Place 7, Texas 14th District Court of Appeals

Justice Ken Wise was appointed to the 14th Court of Appeals by Governor Rick Perry in October 2013. Prior to his appointment, Justice Wise served as the judge of the 334th Judicial District Court, administrative judge of Harris County, and an adjunct professor at the University of Houston Law Center. Justice Wise is also a former judge of the 152nd Judicial District Court in Harris County. Justice Wise is a member of the State Bar of Texas and Houston Bar Association, life fellow of the Texas and Houston Bar foundations, and a member and past president of the Executives Association of Houston. He is also a director of the Houston Livestock Show and Rodeo and the Former Texas Rangers Foundation .



Justice Wise received a bachelor's degree from Texas A&M University and a law degree from the University of Houston Law Center.

Below are some of the topics included in the March Program presented by Council Member Flickinger

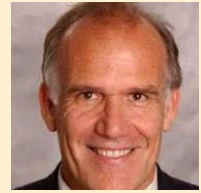
- As the Houston City Council member replacing Dave Martin, who did not seek re-election, Fred has tried to retain as many of Dave Martin's staff as possible. He is bringing on Attorney Mark Mitchell to be part of the District E team.
- The City of Houston reached a historic settlement with the Houston Professional Fire Fighters Association, effectively resolving a long-standing pay dispute. This landmark deal, valued at \$650 million, addresses outstanding pay issues for Houston firefighters dating back to 2017. This settlement raises questions about from where the money will come. Fred believes the 650 million price tag is enormous and needs to be voted on by city residents.
- Fred is focused on Law and Order. The Harris County District Attorney race is critical with **Republican candidate Dan Simons** versus Democratic candidate Sean Teare. This race is vital in transforming the criminal justice system in Harris County. A conservative win in a county that's trended blue in recent years won't be easy.
- Keep an eye out for another challenge to Harris County Constables. The County is trying to absorb them into the Sheriff's Office. This would be a disaster for local communities since each constable serves a specific precinct within the county - not the entire county.
- The Houston Police Department set aside over 261,000 incident reports starting in 2016, and they still don't have the answers people want to know. This is known as the HPD coding scandal which includes sexual assault and property crimes that were never investigated due to "lack of personnel". Fred said the problem was known about before the 2021 timeframe given by Chief Finner.

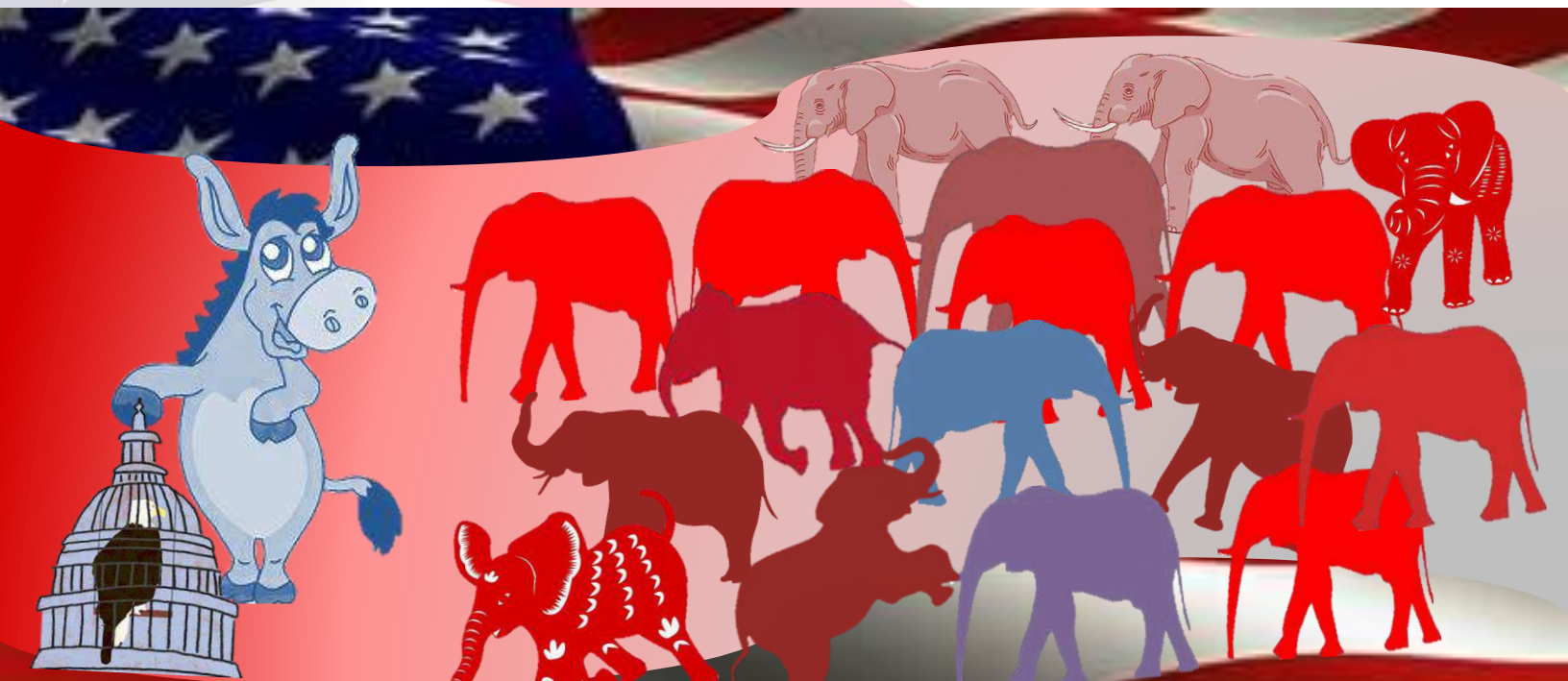

Uniform Elections

A **uniform election date** refers to a specific date on which many local political subdivisions, such as cities, school districts, and water districts, hold their regular general elections for members of their governing bodies or special elections to fill vacancies. These elections are typically scheduled to occur on specific dates to streamline the electoral process and ensure consistency across different jurisdictions.

In Texas, the uniform election date in **May of an even-numbered year** is particularly significant. On this date, various local political entities conduct their regular elections.

May 4, 2024: This year, the **Uniform Election Date** falls on May 4, 2024. On this day, local non-county political subdivisions (such as cities, school districts, and water districts) have the authority to conduct elections. However, county-ordered elections may not be held on this specific date. County election officials may choose to provide election services to political subdivisions holding elections on this date.

By way of explanation, I found the article by Charles Bain at the Texas Scorecard.

Last November's election brought changes to the makeup of the Harris County Appraisal District board, finally giving voters an opportunity to weigh in. Voter-approved Proposition 4 included a provision allowing for the election of appraisal district board members in counties with a population of 75,000 or more. HCAD's board, which, until now, consisted of the county tax assessor-collector and appointed members of the various governing bodies of the county, city, school districts, and community colleges, will add three new elected members to its ranks.

Established in 1980, HCAD is the largest appraisal district in the state and one of the largest in the country. It annually appraises the 1.9 million parcels of property for property tax purposes for each of the nearly 1,000 taxing units within its boundaries.

The election will be held on **May 4**, and new members will take office on July 1 for a term of service that ends December 31, 2026. We will be voting for three At-Large board positions. Place 1, 2, 3.

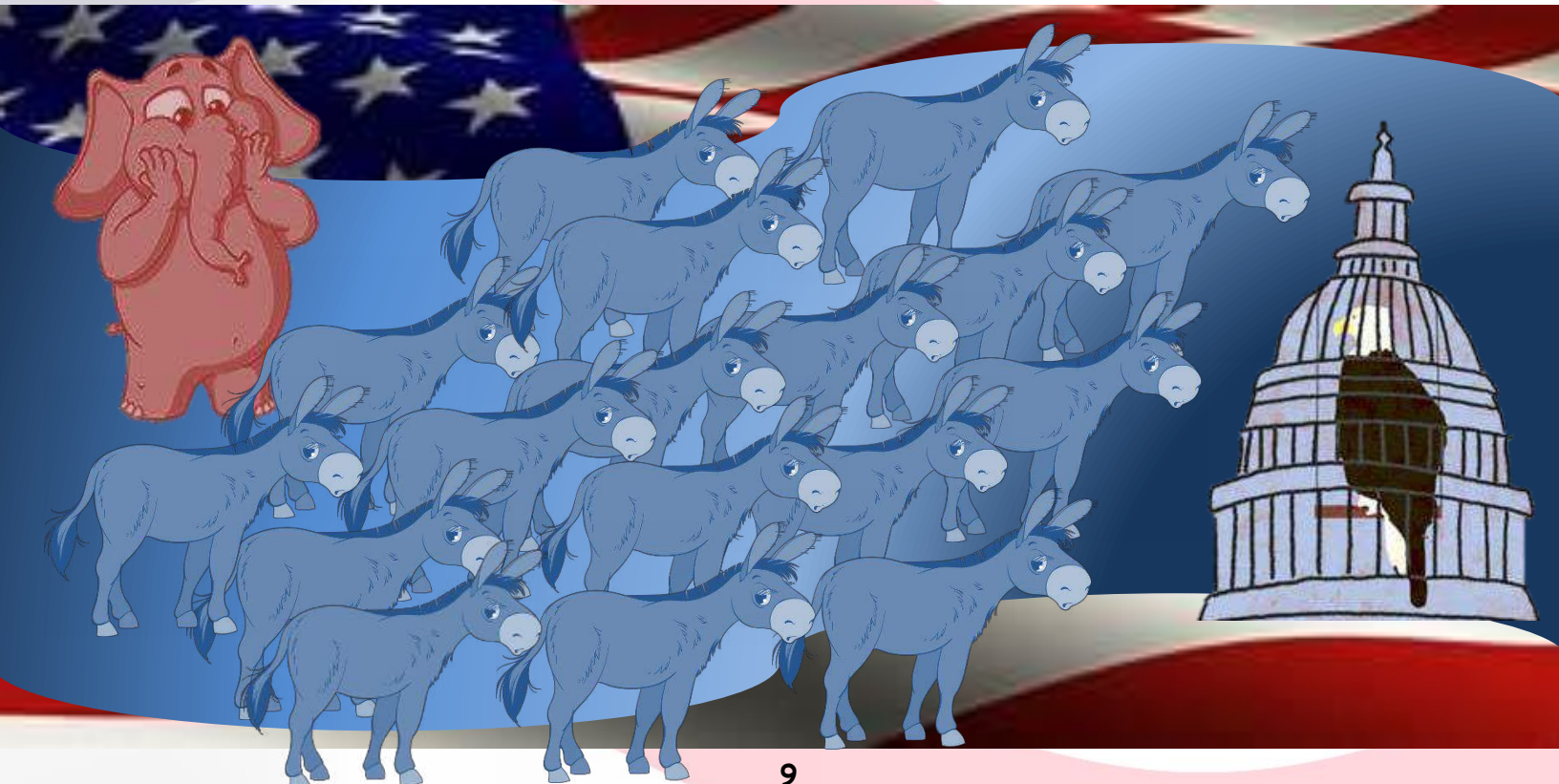

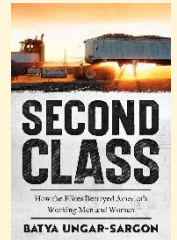

Second Class: How the Elites Betrayed America's Working Men and Women

Who is the American working class? Do they still have a fair shot at the American Dream? What do they think about their chances to secure the hallmarks of a middle-class life?



While writing this book, Batya Ungar-Sargon visited states across the nation to speak with members of the American working-class fighting tooth and nail to survive. In *Second Class*, working-class Americans of all races, political orientations, and occupations share their stories—cleaning ladies, health care aides, cops, truck drivers, fast food workers, electricians, and more. In their own words, these working-class Americans explain the struggles and triumphs of their increasingly precarious lives—as well as what policies they think would improve them. *Second Class* combines deep reporting with a look at the data and expert opinion on America's emergent class divide, in which the most basic elements of a secure and stable life are increasingly out of reach for those without a college education.

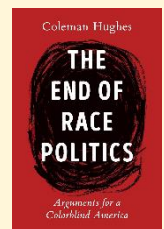
America has broken its contract with its laboring class. So, how do we get back to the American Dream? How do we once again become the land of opportunity, the promised land where hard work and commitment to family are enough to protect you from poverty? It's not that hard actually. All it would take, as this book illustrates, is for those in power to once again respect the dignity of work—and the American worker.

The End of Race Politics: Arguments for a Colorblind America

An exciting new voice makes the case for a colorblind approach to politics and culture, warning that the so-called 'anti-racist' movement is driving us—ironically—toward a new kind of racism.

As one of the few black students in his philosophy program at Columbia University years ago, Coleman Hughes wondered why his peers seemed more pessimistic about the state of American race relations than his own grandparents—who lived through segregation. *The End of Race Politics* is the culmination of his years-long search for an answer.



Contemplative yet audacious, *The End of Race Politics* is necessary reading for anyone who questions the race orthodoxies of our time. Hughes argues for a return to the ideals that inspired the American Civil Rights movement, showing how our departure from the colorblind ideal has ushered in a new era of fear, paranoia, and resentment marked by draconian interpersonal etiquette, failed corporate diversity and inclusion efforts, and poisonous race-based policies that hurt the very people they intend to help. Hughes exposes the harmful side effects of Kendi-DiAngelo style antiracism, from programs that distribute emergency aid on the basis of race to revisionist versions of American history that hide the truth from the public.

Through careful argument, Hughes dismantles harmful beliefs about race, proving that reverse racism will not atone for past wrongs and showing why race-based policies will lead only to the illusion of racial equity. By fixating on race, we lose sight of what it really means to be anti-racist. A racially just, colorblind society is possible. Hughes gives us the intellectual tools to make it happen.

Program: Ann Arnett presented Houston City Council Member Fred Flickinger. Sworn into his first term of office on January 2, 2024, Mr. Flickinger serves communities in District E. In 2023, thousands of cases went without being investigated. The Police Chief's office is being investigated. Constables are being targeted. To show support, please attend County Commissioner Court meetings. The District Attorney race is crucial and conservative candidates require support.

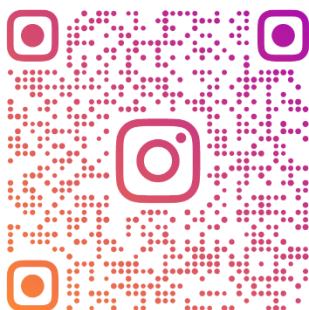
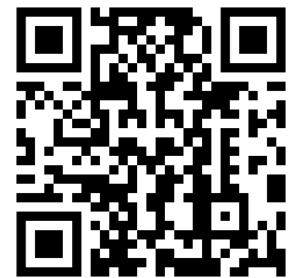
